We request the names, job titles, hourly compensation/annual pay, and hired date for every "per performance" employee employed by the St. Louis City Treasurer's office during the current fiscal year and each of the previous 4 fiscal years. If it's easier to obtain the information by calendar year, we request the same information available since January 1, 2009. As a reference point, current St. Louis City Operations Manager Ron Smith is listed as a per performance employee.

Mr. Cheatem:

The cost to produce the records as requested is \$245.00. The cost breakdown is as follows:

\$180.00 (\$30/year) for IT to run a report providing me with the data requested

\$ 65.00 for two hours of my time to review the data and input dates of hire and job titles

This cost estimate does not include the cost for IT to write the program to extract the data. I have been informed that another city department has included this charge on their cost estimate to you. 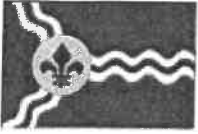
