Lauren- In regards to your Sunshine Law request pertaining to permits:

Request No. 1- We are not in possession of documents in response to your inquiry about Residential parking permits. We do not issue or manage these permits. I would refer you to the Board of Alderman. In response to your inquiry about Business permits, I have attached a spreadsheet outlining our current permits.

Request No. 2- I have attached responsive documents that include parking placards issued to the Treasurer's Office staff, Board of Elections Commissioners, STL Development Corp, and Board of Aldermen. These placards are issued yearly and without a fee. Additional parking exemptions are granted to city departments by ordinance. For example, Ordinance 66788, section 109.10 authorizes employees of the Building Division to park at a parking meter without the payment of fees by displaying a placard. We do not issue or manage any city department placards.

There is no fee associated with this request.
