To whom it may concern,

This is a request for records under the Missouri Sunshine Law, Chapter 610, Revised Statutes of Missouri.

I am requesting the following:

- a) > The total number of parking tickets issued in 2017, 2018, and 2019 (year to date). Such data should specify in each requested period, the total numbers of tickets issued by the Parking Division or any related entity in accordance with City Ordinance, as well as the total number, if any, issued by the St. Louis Metropolitan Police Department, City Marshall's Department and the St. Louis Park Rangers in accordance with City Ordinance, and insofar as such issued tickets are thereafter processed and adjudicated, or otherwise handled by the Parking Division or its related entities.
- b) > The amount of money has been collected from parking tickets in 2017, 2018, and 2019 (year to date).
  - o The aggregate amounts of money collected in each year for parking violations issued by the Parking Division or any related entity the issues such parking violations in accordance with City Ordinance and for which the Parking Division is thereafter responsible for processing, collecting or adjudicating, including the St. Louis Metropolitan Police Department, City Marshall's Department or the Park Rangers.
  - o The information should be reported by funds collected in payment of the original violation amount in accordance with City Ordinance, and list, as applicable, the aggregate amounts of fines assessed and paid in excess of the original violation amount due to delinquent payment by violators.
  - o The numbers from each year of violations issued and later dismissed by the Parking Division or any related entity, either by its own action or as a result of adjudication subsequent to appeal by the recipient(s) of said violation(s).
- c) > All documents which refer to or reflect how many false, fake, or incorrect parking tickets have been issued since 2014 by the Parking Division or any related entity
- d) > All documents which refer to or reflect how many employees have been terminated or reprimanded for issuing false, fake, or incorrect parking tickets since 2014 by the Parking Division or any related entity.

- e) > Any and all documents which refer to any parking meters installed, owned, maintained or administered by the Parking Division or any related entity including contractors working for or on behalf of the Parking Division or any related entity that have caught fire.

The Missouri Sunshine Law requires a response within three business days. If access to the records I am requesting will take longer than this time period, please contact me with information about when I might expect copies or the ability to inspect the requested records.
