To restate:

We are looking for the total salary of the elected official in charge of your office for each of the past 10 years. As of now, we only seek 10 years of salary data for the elected official in charge of the office for each of those years. (We are NOT seeking 10 years of data for ALL office employees, at this time.)

If your agency chooses to redact or withhold any portion of the above records, please include specific reasons, the line in the law that allows for such a redaction, and expedite records that are not being redacted.

The Post-Dispatch requests a fee waiver, if applicable, on the grounds it is doing work that will inform the public of the operations of government agencies.

If the office chooses to charge the Post-Dispatch, please provide us with a detailed breakdown of those costs before compiling the records.
