

This Amendment to Parking Services Agreement (the "Amendment") made and entered into as of this 23th day of September, 2020 (the "Amendment Effective Date"), is by and between Parkmobile, LLC, a Delaware limited liability company ("Parkmobile"), and the Treasurer of the City of St. Louis, Missouri in its capacity as Parking Supervisor ("Parking Supervisor") and the Parking Commission of the City of St. Louis ("Parking Commission"). Parking Supervisor and Parking Commission are referred to collectively as "Client."

**WHEREAS**, Parkmobile and Client entered into a Parking Services Agreement dated August 13, 2015 (the "Agreement"); and

**WHEREAS**, Parkmobile and Client desire to amend the Agreement to reflect certain changed conditions and the new understanding between the parties as set forth below;

**NOW THEREFORE**, in consideration of the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Recitals. The above recitals are hereby incorporated herein.
2. Definitions. Defined or capitalized terms used herein that are not defined by this Amendment shall have their meaning set out in the Agreement.
3. Renewal Term. The parties wish to exercise their right to extend the term of the Agreement for one (1) additional period of five (5) years, which will end on August 13, 2025.
4. Processing Fees. Parkmobile agrees to waive its Transaction Processing Fee for each Transaction made using PayPal or the ParkMobile wallet during the Renewal Term.
5. Signage Refresh. Parkmobile agrees to provide Client with updated Parkmobile signs and decals at no additional cost. For the sake of clarity, installation, and any associated costs, remain Client's sole responsibility.
6. Counterparts. This Amendment may be executed in counterparts, each of which shall be deemed an original, but all of which shall be deemed to constitute one and the same instrument.
7. Entire Agreement. This Amendment contains the entire agreement of the parties with respect to the matters set forth herein and may only be changed by an agreement in writing signed by the Parties. All other terms and provisions of the Agreement remain in full force and affect.
