If such summaries are not available, please provide copies of all invoices submitted to the Treasurer's Office by Xerox State & Local Solutions and Conduent from January 2015 through May 2020, per the terms of Xerox's agreement with the Treasurer's Office dated Jan. 19, 2015.
- Signed agreement with EDC Corporation to provide a Ticket Processing System to the Parking Supervisor, along with all exhibits and attachments. The EDC agreement is referenced in section 4 of the Treasurer's 4/10/20 agreement with Hudson and Associates.
- All meeting materials for Parking Commission meetings, including meeting minutes, for Commission meetings on the following dates:
