attended St. Louis County schools under the voluntary desegregation program. I am trying to find out how many of these city school students were given the opportunity to enroll

in the College Kids program even though they attend county schools, and if so, how many took advantage of this opportunity.

We are not in possession of responsive documents. The College Kids program is offered at City of St. Louis Public Schools and Charter Schools.

2) Copies of all documents regarding the enrollment of St. Louis County school children who attend St. Louis Public Schools magnet schools in the College Kids College

Savings Program. I am trying to determine how many of these county schoolchildren were given the chance to enroll in the College Kids College Savings Program and, if so, how many took advantage of this opportunity.

We are not in possession of responsive documents. We do not receive student addresses and are not informed as to whether they live in St. Louis County.

3) Documents showing the overall number <u>and</u> percentage of this number of accounts in the College Kids Savings Program that are at the \$50 seed level for the following school years: 2018-19, 2019-20, 2020-21 and 2021-22. In its 2020 audit of the Office of St. Louis City Treasurer, the Missouri State Auditor had determined that 75 percent of all College Kids accounts remained at the \$50 seed level. I am trying to determine if this percentage has gone up or down since then.

You have already been provided a report in response to your request dated March 6, 2023. We have no additional responsive documents.

4) Documents showing the overall number <u>and</u> percentage of this number of accounts in the College Kids Savings Program that are at the \$500 level for the following school years:

2018-19, 2019-20, 2020-21 and 2021-22. The \$500 level is an important milestone because, as the treasurer's office literature states, saving at least this amount for college dramatically increases a child's chances of attending an institution of higher education.

You have already been provided a report in response to your request dated March 6, 2023. We have no additional responsive documents.

5) Documents showing the overall number <u>and</u> percentage of students in the College Kids program who received full attendance incentive deposits for the following school years: 18-19, 2019-20, 2020-21 and 2021-22.

We do not track the overall number and percentage of all students who receive full attendance incentive deposits. Some attendance incentive information can be found in the College Kids Annual Reports https://stlofe.org/college-kids/.

6) Copies of all opinions and memos from legal counsel since Jan. 1, 2015 to Jan. 1, 2023 submitted to the Office of St. Louis Treasurer regarding how the College Kids program is affected by the Family Educational Rights and Privacy Act, or FERPA. This is the federal law that gives parents the right to have some control over the disclosure of personally identifiable information from the education records of their children.
