**ADDENDUM 1 TO
AGREEMENT BETWEEN
THE TREASURER OF THE CITY OF ST. LOUIS, MISSOURI,
IN HER CAPACITY AS PARKING SUPERVISOR,
THE PARKING COMMISSION OF THE CITY OF ST. LOUIS,
AND EDC CORPORATION
FOR
PARKING MANAGEMENT SOFTWARE
DATED NOVEMBER 25, 2019**

The Parking Commission of the City of St. Louis (Licensee) hereby authorizes services to be provided by EDC Corporation (Licensor) in addition to those identified in the "Proposed AIMS Software" as described in Exhibit B to the Agreement. These services are specifically:

1. Print and Mail services for statements and collection notifications produced from the AIMS software system. Printing to be provided on 8.5 inch by 5.5 inch white 10 PT postcard stock, with printing on both sides. Mailing will be via United States Postal Service at the presorted rate.
2. Bluefin Credit Card transactions for card present and internet based credit card payments. Funding of these transactions will be through the vendor of the Licensee choice (presently Chase Paymentech).
3. Out of State Registered Owner Plate Lookups – Registered Owner lookup for all states with the exception of Missouri and Utah. Automated file transfers for plate request files and returned name and address files. Licensee may restrict requests to only those states they desire. Some states require additional authorization forms to be completed which will be provided by the Licensor as required.

Fees associated with these services will be invoiced and paid separately from the license fee identified in Exhibit B to the Agreement. These fees will be invoiced monthly for the preceding month, with Net 30 days due terms.

Licensor guarantees the above pricing for the period of one (1) year from the date of this Addendum, with the exception of the postage fee which will be charged at the then current published United States Postal Service presorted rate at the time of the mailing. The Setup fee will be charged on the first monthly invoice once the associated service is utilized.

Licensor can configure the AIMS software to add any of these fees (or other amount) to the customer transaction as may be desired by the Licensee.
